Trip4Asia Sdn. Bhd. ("Trip4Asia" or "we") welcomes you (the "Customer" or "you") to its website or application (the "Site" or "App"). References to the Site or App are derivatives thereof, including but not necessarily limited to mobile websites and applications. The Terms of Use —as defined below- apply to our services, directly or indirectly made available to you through whatever means, including online reservations, customer service requests or otherwise. By accessing, browsing and using the Site or App and/or by making a reservation through Trip4Asia, you acknowledge and agree having read, understood and agreed to the Terms of Use. Our different policies and guidelines, which can be found throughout the Site or App, including but not limited to, the Personal Data Protection Notice & FAQs, etc. (collectively the "Policies"), should be read in conjunction with and are an integral part of these terms and conditions and are hereby included by reference. 3. Prices & Additional Charges

A. Additional Charges by Operators or Vendors

Please note that all prices on the Site or App are for your booking reservation only and are for the requested dates only and for the number of people indicated, unless indicated otherwise. 4. Standard Amendment and Cancellation Policy
